

2025 Reclamation Chapter of the Year Petition

AWARD INSTRUCTIONS

The Southern Province Reclamation Achievement Award is the province award available to alumni chapters for reclamation efforts and achievement. The alumni chapter submitting must have at least ten (10) members who are in good standing with the Grand Chapter, Southern Province, and the local alumni chapter of Kappa Alpha Psi Fraternity, Inc. at the date of their submission. The Reclamation Committee will issue awards according to the criteria listed below in each chapter category:

Awarded to a chapter for most reclaimed members based upon actual number of members reclaimed.

A.) A chapter with at least <u>10 but not more than 30 members</u> in good standing with the Fraternity at the Grand Chapter, Province and chapter levels is in the **small chapter** category;

B.) A chapter with at least <u>31 but not more than 60 members</u> in good standing with the Fraternity at the Grand Chapter, Province and chapter levels is in the **medium chapter** category;

C.) A chapter with <u>more than 61 members</u> in good standing with the Fraternity at the Grand Chapter, Province and chapter levels is in the **large chapter** category.

The total number of members in "Good Standing" reported by the chapter will be verified by the Southern Province Achievement Committee by contacting IHQ to verify accuracy.

If there are two or more chapters in the same category with the same number reclaimed it will be decided by the greater percentage of the chapter total membership reclaimed.

a. Verification of proper reclamation must be attested to by the chapter Polemarch and Keeper of Records and Exchequer. Include evidence of this with your submission.

The completed form must be submitted to the Reclamation Committee Chairman. Consideration will be given only for chapters submitting and for brothers reclaimed from the 2024 Province Council to 2025 Province Council. Deadline for submission is February 8, 2025

A reclaimed member is any member who has become active after not complying with Article XXV Section 12 of the Constitution and Statues on all three levels for at least (2) two years.


