- ♦ Make sure page 6 **(alumni), Part III: Areas of Achievement** or page 7 **(undergraduate only) Part IV: Areas of Achievement** is the fourth page of the submitted Chapter of the Year Award Petition. Chapters can use as many pages as deem necessary to give unique and creative style to the responses of the petition questions.

**The email deadline for all electronic petitions to be in compliance of the rule will be Saturday, March 7, 2026 at midnight. NO EXECPTIONS!**

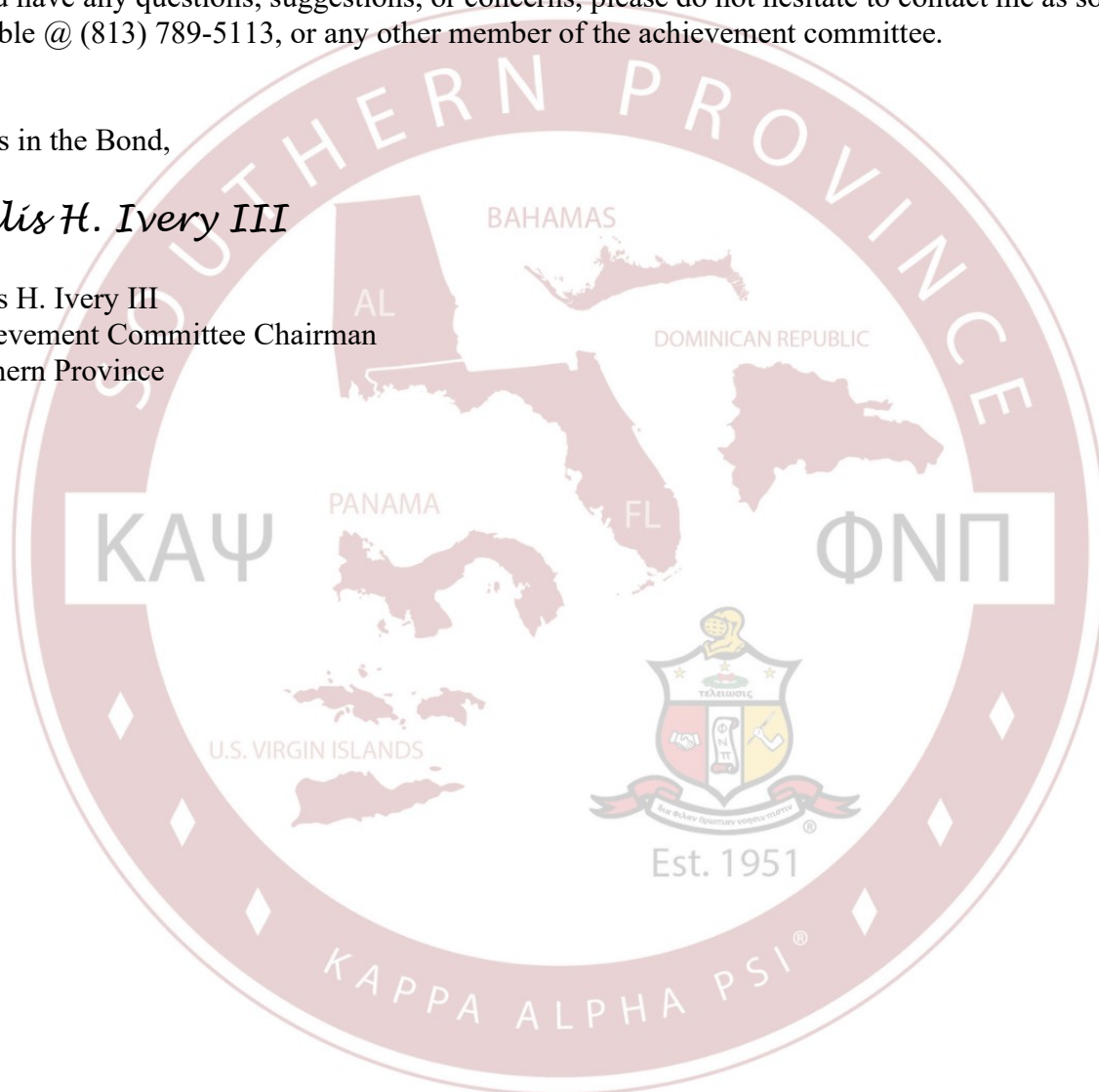
